# **Assessment Advice for Students and Parents - Remote Learning COVID19**

The NSW Education Standards Authority (NESA) Board confirmed that the Higher Certificate (HSC) is going ahead in 2020. Both NESA and Department of Education are providing updates regularly. Information may change. We will provide new advice as it comes to hand.

#### **Assessment Tasks**

Students in years' 7-12 should continue to work on assessments. Due to the move to a remote learning environment, revised notifications of changes to the nature of the task or the due dates will be issued through the google classroom. Hard copies will be contained in work packs. A number of current assessments have been granted extensions or have been modified.

At this stage in Term 2, Plumpton High School will assess students using the following methods:

#### Year 7- 10:

There will be no formal assessment tasks for Year 7-9. Year 10 will still need to complete formal assessment tasks. Students will be given feedback on all work submitted via Google Classroom or hardcopy. Work samples will be collected and if necessary, judgements can be made against NESA Band Performance Descriptors and reported on. There will be no grades included on reports at the end of Semester 1. We will be reporting on a range of skills for Year 7-10, including student submission rates.

#### **Year 11:**

Assessment tasks, dates and weightings may be modified from the current assessment schedule. Students will be provided with feedback on all work submitted via Google Classroom or hardcopy.

#### Year 12:

Currently the 2020 HSC will continue in line with NESA advice. Assessment tasks, dates and weightings may be modified from the current assessment schedule. Students will be provided with feedback on all work submitted via Google Classroom or hardcopy.

#### **Special Considerations Process**

Students at Plumpton will not be disadvantaged in any way with reference to assessment. Individual circumstances that impact student learning and assessment will be considered through the Application for Special Consideration process.
